NOTE 1. RESPONSIBILITY OR COMMITMENT

In accordance with Colombian immigration regulations, the employer or contracting party, without prejudice to the immigration regulations deriving from compliance of the contract, services rendered, interadministrative contract, or administrative act, undertakes before the National Government, to pay for the return expenses to the country of origin or residence of the foreigner under contract or with a labor link, as well as his/her family, as applicable, at the end of contract, labor link, transfer period, or in situations that may hinder the work or duties in the contract, or when the cancellation of visa, deportation or expelling occur.

NOTE 2. REGULATED PROFFESIONS

As enshrined in current Colombian regulations, whenever the activity deriving from compliace of a contract, services rendered, interadministrative contract, or administrative act corresponds to that of a regulated proffession, the contracting parties must comply with the established legal requirements for the exercise of each profession or occupation within the national territory.

NOTE 3. PERSONAL DATA PROTECTION

The Ministry of Foreign Affairs and its Revolving Fund, in compliance with Law 1581 of 2012 "*By which general provisions for the protection of personal data are established*", is responsible for the processing of your personal data.
